PROJECT LUNCHBOX IS A WEEKEND FOOD PROGRAM FOR KIDS IN K-8TH GRADES IN NEW ULM PUBLIC SCHOOLS. IT IS ALSO PROVIDED TO THE RIVERBEND DISTRICT, NEW ULM CATHOLIC SCHOOLS, AND ST. PAUL'S. THIS IS OUR EIGHTH YEAR PROVIDING THIS MUCH-NEEDED NEW ULM SCHOOL DISTRICT PROGRAM. ORGANIZING THE DRY GOODS, PURCHASING, AND OVERSEEING THE PROCESS OF PACKING AND DISTRIBUTING THE FOOD IS MONUMENTAL. THE FOOD IS PACKAGED AND DELIVERED TO SCHOOLS FOR KIDS WHO QUALIFY FOR FREE OR REDUCED LUNCHES. THE FOOD PACKAGES ARE THEN PLACED IN A CHILD'S BACKPACK ON FRIDAY TO BE TAKEN HOME. WITH A STEADY CORE OF VOLUNTEERS, THESE FOOD PACKAGES INCLUDE TWO MEALS, TWO SNACKS, AND TWO BEVERAGES TO GET EACH CHILD THROUGH THE WEEKEND. AN ARMY OF VOLUNTEERS IS INSTRUMENTAL IN THE EXECUTION OF THIS PROGRAM. HUNGER CAN IMPACT YOUNG CHILDREN, CAUSING ANXIETY, POOR BEHAVIOR, AND IMPAIRMENT TO LEARNING, AND FOOD INSTABILITY IS A REAL PROBLEM IN THE BROWN COUNTY AREA. PROJECT LUNCHBOX PROVIDES THE VITAL NUTRITION THAT STUDENTS NEED FOR SCHOOL SUCCESS. THIS YEAR WE ALSO PROVIDED \$5000 IN FUNDING TO THE SLEEPY EYE FOOD SHELF AND THE SPRINGFIELD FOOD SHELF FOR THEIR WEEKEND FOOD PROGRAMS.
